Waiver of Liability, Indemnification and Release

I have agreed to participate in a summer soccer camp offered through the Buffalo Soccer Club, facilitated by Steve Doimer. The camp dates are June 18, 20, 25, 27 and July 9, 11, 16, 18, 23, 25, 30, 2010. My participation is wholly and completely voluntary. I am aware of the risks to my person and property involved in participating in this event. Risks associated with this event include, but are not limited to, physical injury or impairment, bruises, sprains, contusions, fractures, internal injury, heart attack and the possibility of death. All such risks are known and understood by me.

I agree as follows:

- 1) I, individually, on behalf of my heirs, successors, assigns and personal representatives hereby release and forever discharge the Buffalo Soccer Club, Steve Doimer and any associates involved in the facilitation of activities, from any and all liability whatsoever for any and all damages, losses or injuries (including death) I sustain to my person or property or both, including but not limited to any claims, demands, actions, causes of action, judgments, damages, expenses and costs, including attorney fees, which arise out of, result from, occur during, or are connected in any manner with my participation in the High School Soccer League whether caused by the negligence of the releasees or otherwise; except that which is the result of gross negligence and/or wanton misconduct of the releasees.
- 2) I, individually, and on behalf of my heirs, successors, assigns and personal representatives, hereby agree to indemnify, defend and hold harmless the Buffalo soccer Club, Steve Doimer and any associates involved in the facilitation of activities, from any and all liability, loss damage or expense, including attorney fees, that they or any of them incur or sustain as a result of any claims, demands, causes of action, damages, judgments, costs or expenses, including attorney fees, which arise out of, occur during, or are in any way connected with my participation in the high school soccer league.

I agree that this waiver Release and Indemnification Agreement is to be constructed under the laws of the State of Minnesota, USA, and that if any portion thereof is held invalid, the balance hereof shall, notwithstanding, continue in full legal force and effect. I agree that this agreement is to be constructed broadly to provide release, indemnification and waiver to the maximum extent permissible under applicable law. In signing this document I hereby acknowledge that I have read this entire document, that I am at least eighteen (18) years of age, that by signing it I am giving up substantial legal rights I might otherwise have, and that I have signed it knowingly and voluntarily.
